### Notice of purchasing own shares through ToSTNeT-3

Shimadzu Corporation (“SHIMADZU”) has decided at the meeting of the Board of Directors held on May 10, 2024 to purchase own shares pursuant to Article 156 of the Companies Act after applying the regulations of Article 165, Paragraph 3 of said law. SHIMADZU hereby announce its determination of the specific method of purchase for a part of them as follows:

#### 1. Method of purchase

SHIMADZU will place purchase orders for own shares through brokerages on the Tokyo Stock Exchange Trading Network Off-Auction Own Share Repurchase Trading System (ToSTNet-3) at 8:45 a.m. session on December 4, 2024 (no changes to the trading system or trading time will be made), at a price equal to the closing price of the company’s common shares on the Tokyo Stock Exchange on December 3, 2024 (4,311 yen). This purchase order will be valid only for the time mentioned above.
